designated dates, or in the event of damaged	or imperfect film or equipment, The owner agrees to the	best of the owner's ability
to accommodate [NAME] in granting the right	t to use the premises at a later date to be mutually agree	d upon. This grant of location
rights is in connection with the motion picture	e photoplay tentatively entitled [],	and includes the right to re-
use the photography in connection with other	r motion picture photoplays as you, your successors, assiş	gns and licensees shall elect,
and, in connection with the exhibition, promo	tion, advertising and exploitation thereof, in any manner v	vhatsoever and at any time
and in any part of the world. Similarly, [NAME	E] agrees to hold the owner free from any claims for liabil	ity, damage or injury arising
during occupancy of the premises and arising	out of your negligence thereon on the aforementioned d	ates; [NAME] further agrees
to leave the premises in as good order and co	ndition as when received, excepting reasonable wear, tea	r, force majeure, and use. The
owner acknowledges that, in photographing t	he premises, [NAME] is not in any away depicting or port	raying the owner in the motion
picture photoplay, either directly or indirectly	. The owner guarantees hereto that he will not assert or	maintain against [NAME] any
claim of any kind or nature whatsoever, include	ding, and without limitation, those based upon invasion of	privacy or other civil rights,
defamation, slander or libel, in connection wit	th the exercise of the permission herein granted. Further,	the owner represents that he/
she/they is/are the actual and legal owner(s)	and/or authorized representative(s) of the premises, and	thereby has the authority to
grant to [NAME] by pen the permission and ri	ights herein specified, and that the permission of no other	party is required.
